Confirmation of booking

The Bridge Garden Bar does not accept '*tentative*' bookings due to the high demand of our venue. To avoid disappointment you must hand in your completed function agreement form and pay the agreed upon deposit as soon as possible. If these have not been received by management **within 48 hours** of the initial consultation, we reserve the right to allocate areas to another booking. Food and beverage options must be confirmed no less than seven (7) working days before your booking date.

Deposit

A minimum non-refundable deposit equivalent to room hire is required to confirm a function booking. Credit Card details must also be provided. Provided there are no damages caused by the host or their guests, the deposit can be used towards the cost of food, beverages or room hire. For bookings of up to 49 a deposit of \$200 is required and of bookings of 50 and over a \$500 deposit is required.

Cancellation

Four (4) weeks minimum notice is required to cancel your event, anything under Four (4) weeks will forfeit your deposit in full and any cancellations with less than two (2) weeks notice will forfeit 50% of the function total as well as the full deposit amount

Minimum Spend

All function areas require a minimum spend amount on food only if you wish to have the area **exclusively** for your group. Failure to reach minimum spend may result in your credit card being charged to reach the agreed upon value. Please note that booking for set menus will be charged at the confirmed numbers or actual amount of attendees, whichever is greater.

Payment

Full payment is required 48 hours prior to the commencement of your booking, excluding bar tab, unless prior arrangements have been made. For your convenience we accept payment by cash, visa or mastercard. Please note that credit card surcharges do apply.

Guaranteed Numbers

For catering purposes we request that final numbers are confirmed seven (7) working days prior to your booking. **If your guaranteed numbers decrease drastically from the initial consultation you will still be responsible to meet the original agreed upon value of the minimum spend. If your guaranteed numbers increase please check with management that we will be able to accommodate additional guests from the initial consultation (additional fees may apply).**

Decorations

Any decorations must be approved by management and can only be fixed with Blu-Tack. The event organiser is responsible for any damages caused by any decorations. At no point is glitter, confetti or party poppers to be used, if this occurs damages and a cleaning fee will be charged.

Music/Entertainment

Any music and/or entertainment must be discussed with management at the time of your booking.

Responsibility

No liability is accepted by The Bridge Garden Bar or their staff for the loss or damage of patrons/property. The organiser is responsible for the behaviour of their guests and any damage caused by themselves or their guests.

Behaviour

Management reserves the right to end any function or eject any/all guests. You will lose all function payments if appropriate behaviour is not observed by all guests and be charged for any damages.

Refusal of Service

Management reserves the right to refuse anyone entry or supply of alcoholic beverages attending the venue that are underage, intoxicated or displaying suspicious or offensive behaviour in accordance with our in house policy and the Liquor Control Act 1988.

Food & Beverages

- All food and beverage is to be supplied by The Bridge Garden Bar, the ONLY exception is if you would like to provide your own cake or cupcakes. Cakes can only be brought into the venue on the day of your booking. The Bridge Garden Bar does not take any responsibility for this cake.
- As we are a licensed venue, no drinks or alcohol is to be brought from outside into the venue at any time, in accordance with the Liquor Control Act 1988.
- No food or beverages are to be taken off premises at any time.

Security

Due to Liquor Licensing Laws, functions over a certain amount are required to have licensed crowd controllers for the duration of the function at the organisers cost. This we can arrange for you with seven (7) days notice, speak to your Functions Manager for more details.

Minors

All underage guests must be under strict supervision at all times by a parent or legal guardian, must remain in the designated function area and must leave the premises by 9pm. Underage guests MUST NOT consume alcohol, and if are found to be doing so, will be asked to leave immediately.

ID Checking

It is very important to note that all patrons that look under the age of 25 will be requested to show ID before being served any alcoholic beverages. It is not meant to be offensive, rather, as a compliment. Please make sure all guests are aware of this and have valid identification with them at the time of your booking.

Wedding Packages

Wedding Packages are available from \$85p/p, this includes food, full table service, linen, set up & pack down, cake & gift table etc, Please talk to your Functions Manager for more information

18th Birthday Parties

As of **September 2020** The Bridge Garden Bar is no longer taking function bookings for 18th Birthday parties due to problems that have arisen with previous functions. We apologize for any inconvenience this may cause.

Garden Bar Bookings

If you choose to book your function in the Garden Bar please bear in mind that there is no shelter from the weather and if on the day of your function the weather is unfavourable The Bridge Garden Bar will try their best to find an alternate area/option for the function to proceed but due to the popularity of our venue, other alternatives may not be available. If the function organizer decides to cancel the event due to weather, The Bridge Garden Bar is released of any/all liability of customer loss in the process of canceling the function. The function organizer understands that any booking cancelled with less than 48 hours notice will forfeit any monies set out under our cancellation policy.

By signing the agreement you are taking responsibility for all of your guest's behaviour and for all of the conditions contained in this agreement.
